City Commission Archive Search Tips

Archive documents available via this portal can be accessed by **(1)** selecting one of the pre-defined queries and **(2)** inputting a date range or search terms, or a combination of both. It is recommended to always provide a starting date (i.e. “From Date”).

Search Limitations: Only 500 matches will be shown. If your search parameters are too broad and too many results are found, the following message will be displayed at the top of the search results:

There are more results than what is displayed. Please narrow your search criteria.

If this occurs, you must narrow your search by decreasing your date range, or by providing additional search parameters to limit the number of items matching your search criteria.

Step 1: Select a pre-defined query from the list from the “Search Type” drop-down menu:

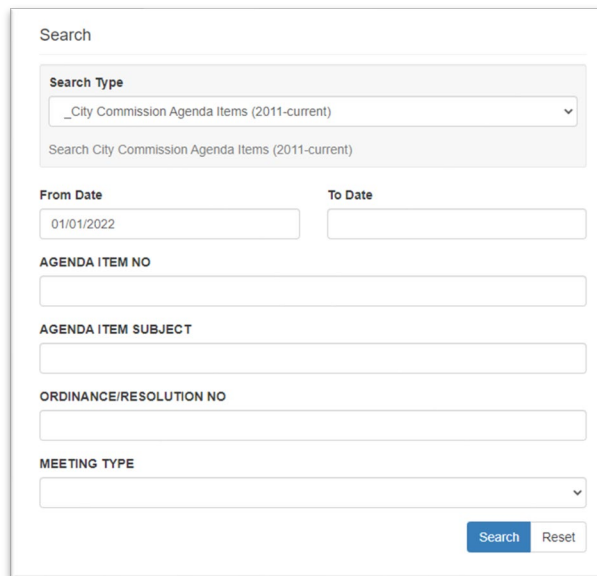


Image 1: Search panel

The available **Search Types** are:

- City Commission Agenda Items
 - This search can be used to locate copies of agenda items from 2011 onward.
- City Commission Closed-Caption Transcripts
 - This search can be used to locate closed-caption transcripts of Commission meetings broadcast on television from April 2019 onward. These transcripts may be downloaded and are keyword searchable.
- City Commission Minutes
 - This search can be used to locate copies of approved minutes of City Commission meetings. Minutes in this search are filed by individual meeting, indexed by a specific meeting date, meeting type, etc.
- City Commission Minutes (Year-by-Year)

- This search can be used to locate bundled copies of minutes for an entire calendar year. One file is available for each year from 1920 onwards, in PDF format. A new yearly file is posted each March for the preceeding year (e.g. the file for 2022 calendar year file will be available in March of 2023)
- City Commission Ordinances & Resolutions
 - This search can be used to locate ordinances and resolutions adopted by the City Commission from 2011 onward. Ordinances or resolutions that were rejected by the Commission are not available via this search. Items may be located by the specific number assigned to Ordinance or Resolution. The specific number can be found in the corresponding Agenda Item, or in the footnotes of the published [Charter & City Code Book](#).

Step 2: Enter a starting date, or date range

The portal will automatically set the “From Date” to the first day of the current calendar year. You may adjust this date according to your needs. If you know a specific date range, please input it. To improve search performance, a “From Date” should always be specified.

Step 3: Enter other limiting criteria

General search strategies

Searches are NOT case sensitive. You may use lowercase or uppercase letters, or both.

Always input a “From Date”. If you know a specific timespan, it’s helpful to also input a “To Date.”

Agenda Items:

To aid in searching Agenda Item content, the data is organized and indexed in a structured fashion. The below provides general search guidance. Adding the asterisk (*) character after a search term (see chart below) will locate items that begin with that search term. For example, the search term **TAL*** will locate matches starting with “TAL” and may include items beginning with tall, tallest, taller, Tallahassee, Talquin, etc.

Ordinances & Resolution numbering:

Since the 1960s, Ordinances & Resolutions have been numbered with a 2-digit prefix representing the calendar year during which a particular topic or matter surfaced. For example, Ordinance 12-O-02 was the second ordinance number assigned during calendar year 2012.

Additionally, the Ordinance number was formatted to be two digits, a center letter, and a sequential number – with each element separated with a hyphen or dash. The center letter is typically an “O” for Ordinance, “R” for Resolution, or “Z” for Rezoning. Early ordinances (1980s) contained center letters of “M” for a rezoning Land Use Map Amendment. However, this numbering style is no longer used.

In some instances, ordinances are amended during the time period from their first reading (introduction) and their final adoption at a public hearing. In such instances, the suffix “AA” is appended to the ordinance number to signify the adopted ordinance is “as amended” during the public hearing process. Therefore, you may need to search for an ordinance number both with and without the “AA” suffix (e.g. search both 12-O-18 and 12-O-18AA)

Example Ordinance & Resolution Numbers:

- 12-O-34AA – 2012 Budget Ordinance (as amended) - City & DIA final budget - FY2013
- 16-Z-01 – 2016 Rezoning Ordinance - 212 Young St (Jake Gaither House)
- 18-R-25 – 2018 Resolution for Glenview Dr Sidewalk Project

Antiquated numbering (discontinued after ?)

- 90-M-0070 – 1990 Rezoning Ordinance - Governors Sq Blvd / Park Ave (Land Use Map)
